NOTIFICATION

In the interest of the academic growth of the Institute, the Competent Authority of NERIST has accorded an approval for the 2nd Spot Counselling-cum-Admission for vacant seats in the UG and PG Programmes from 2025-26.

The 2nd Spot counselling cum admission will be operationalised and shall be held on 25.07.2025 for the candidates provided vacancies exist in the particular course, subject to the following conditions:

- 1. The names of the candidates eligible for the 2nd Spot Counselling cum Admission shall be displayed on the website as per the performance on NEE 2025 / NEPGET 2025.
- 2. Candidates must be present IN PERSON with all the required documents; no representatives shall be allowed.
- 3. Admission shall be done based on the merit list of the respective courses/programmes and by following the extant of the reservation policies of the Govt of India for both UG and PG Programmes on the available
- 4. The candidates who already got the admission are not eligible for the 2nd Spot Counselling cum Admission.
- 5. Candidates must meet the specific eligibility criteria set by the Institute and the programmes for which they are applying for. The admission criteria, fees, etc shall be the same as normal admission, except that an additional non-refundable registration fee for on-spot admission of Rs 1500/-(One Thousand Five Hundred) only shall be charged to the candidates who register and participate in the 2^{nd} Spot Round.
- 6. The list of the eligible candidates and the vacancy status shall be uploaded on the Institute website (https://nerist.ac.in/) on 21.07.2025. The eligible candidates are required to fill up the Counselling-cum-Admission form by registering into https://students.targetx.in/NERIST/ from 21st July 2025, and by making a payment of Rs 1,500/- (Non- refundable counselling fee). The interested candidates need to report the Counselling Venue at 9.30 A.M positively on 25.07.2025 with the printed copy of the counselling form & the required documents. The candidates are required to visit the Institute websites regularly for updates, if any.
