

<b>II</b>	All the non-APST Candidates, which will include: a) Children of non-APST State Govt. employees b) Children of non-APST All India Central Govt. and Public Sector Undertakings serving in the State. c) Children of all others not included in above categories, residing in the state for last 3 years and should have passed class X/ XII or equivalent from any of the schools within Arunachal Pradesh	<b>20%</b>

The Governor of Arunachal Pradesh is further pleased to reserve all the seats received from the regional bodies / institutions within the North-East for APST candidates only i.e. Category-I.
