Subject: Clarification regarding Reservation Policy and Allotment of State Quota Seats for NEE-reg

Sir,

With reference to your letter regarding clarification on the reservation policy and guidelines pertaining to the allotment of State Quota seats for Sikkim candidates, the matter has been examined in consultation with the competent authority.

In this regard, the following clarifications are conveyed:

Allocation of vacant reserved seats:

In the event that no eligible candidate is available under a particular reserved category, or if seats remain vacant under such category, the same may be converted into merit seats. Thereafter, such seats may be allotted to eligible candidates belonging to Sikkim strictly on the basis of merit, in line with the prevailing practices adopted for State Quota seat allotments.

Utilization of vacant category-specific seats:

Seats earmarked for a particular category, if remaining vacant, may be reallocated among Sikkim candidates on merit basis to ensure optimal utilization of available seats.

Applicability of Notification dated 26/06/2025:

The Notification No. GoS/DTE/2016/89/Pt-III/2125 dated 26/06/2025 shall be applicable to all courses covered under the State Quota seats by the Government of Sikkim. This includes not only MBBS, BDS, BASLP, BHMS, and BVSc & AH, but also Engineering, Technology, and other courses, as clearly indicated in the said notification.

You are requested to take necessary action for implementation of the above from the current academic session.
