Sub:- Reservation policy of the State of Nagaland quota seats for admission through NERIST Entrance Examination (NEE-2026) reg.

Sir,

In a partial modification to the Nagaland State Quota seats for admission through NERIST Entrance Examination as required by your esteemed Institute, below is the reservation policy w.r.t. the State of Nagaland in NEE-I, NEE-II (PCM), NEE-II (PCB) & NEE-III.

1. The State of Nagaland provides 15% reservation of the total no. of seats in each level of entrance examination to Tribes mentioned in the table-II based on the entrance merit. Also, 5% reservation to people with Disabilities (PwD) for candidates mentioned in the Table-I & Table-II.
2. The 5% PwD candidates is drawn from both 85% reservation & 15% reservation respectively i.e. there are two types of PwD candidates, one for the tribe mentioned in table-I and the other for the tribes mentioned in table-II.
3. If there are no candidates belonging to the tribes mentioned in table II, the seats are de-reserved and allotted to the tribes mentioned in table-I.
4. Also, if there are no PwD candidates in respective entrance level, the seats are to be de-reserved and allotted to tribes mentioned in both the Table-I & Table-II based on merit of the entrance examination.
5. The remaining 85% of the total no. of seats in each level of entrance examination is open to all the tribes i.e. all the tribes either from Table-I or Table-II based on the merit of the entrance examination.
6. Only if any seats remain unfilled even after applying the above clauses i.e. Sl. 1,2,3, 4, 5, the seat would be offered to candidates fulfilling the condition mentioned below: -
 - a. Candidates belonging to the non-local Indigenous inhabitants of Nagaland as per P & AR Department Notification No.AR-8/8/76 dated 28th April, 1977.
OR
 - b. Children of Non-Local State Government employees and children of All India Service Officers borne on Nagaland Cadre to be eligible, the candidates should have appeared/ passed class X/XII or equivalent from any of the school within Nagaland AND his / Her parent(s) should have been residing and posted in Nagaland for at least 3 (three) years or more. Both the criteria should be fulfilled.

NOTE 1. With respect to Rongmei Tribe mentioned in Sl. No. 10 of table I, only 1313 descendants already identified by the Govt. of Nagaland through special enumeration process as having permanently settled in the present territory of Nagaland prior to 01-12-1963 along with their legitimate descendants are eligible to avail state reservation quota. In the event if there are any issues pertaining to identification of the eligible criteria of Rongmei candidates, this office may be consulted to identify the genuineness of the candidates.
